1. NO EVIDENCE TO DATE OF TRAVEL TO MEXICO BY AMPALM 26 DURING 1963.

2. FOLLOWING VOLUNTEERED BY CHIEF ODENVY IN MEXICO, ON EVENING 13 JANUARY IN HIS ORAL REVIEW TO COS OF CURRENT PROBLEMS IN THEIR INVESTIGATIONS OF LEADS PERTINENT TO LEE HARVEY OSWALD CASE:

A. ODENVY HEADQUARTERS SENT CABLE TO MEXICO STATING (AMPALM/26) WAS SOURCE OF ANALYSIS PREPARED BY CUBAN PSYCHOLOGIST, JOSE I. LASAGA OF MIAMI.

B. ODENVY INTERVIEWED (AMPALM/26) WHO SAID: SYLVIA DURAN TOOK LEE OSWALD TO CABALLO BAYO RESTAURANT... NEAR CHAPULTEPEC GOLF CLUB WHERE THEY MET CUBAN AMBASSADOR TO MEXICO, JOAQUIN HERNANDEZ ARMAS. HAUN HERNANDEZ ARMAS TOOK OSWALD FOR A RIDE IN HIS CAR SO THAT THEY COULD TALK PRIVATELY.

C. (AMPALM/26) TOLD ODENVY HIS SOURCE WAS EDUARDO BORELL NAVARRO, MEXICAN NEWSPAPERMAN WHO WRITES EDITORIALS FOR EXCELSIOR.

D. CHIEF ODENVY SENT MATTHEW CRAWFORD, ASSISTANT, TO INTERVIEW BORELL NAVARRO ON 12 COPY.

E. BORELL NAVARRO SAID¹ (AMPALM/26) HAD "IMAGINED" WHOLE STORY. BORELL NAVARRO SAID HE DID NOT REPEAT NOT KNOW ANY MORE THEN THAT OSWALD HAD BEEN TO MEXICO AND HAD VISITED THE CUBAN EMBASSY AND SYLVIA DURAN. BORELL NAVARRO SAID EVERYTHING HE KNEW HAD BEEN PUBLISHED AND WAS PUBLIC KNOWLEDGE.

3. CHIEF, ODENVY,² MEXICO SAID HE KNEW (AMPALM/26)¹ WELL WHEN BOTH WERE IN HABANA. HE SAID AMPALM/26¹ "NOTED FOR REPORTED BASED UPON HIS INTUITIVE FEELINGS" AND VERY RARELY REPORTED FACTS.

4. BELIEVE ODENVY TOLD AMPALM/26¹ HE HAD BEEN CITED TO THEM AS SOURCE BY JOSE I. LASAGA.
