IN LIGHT OF DEVELOPING HOUSE COMMITTEE INVESTIGATIONS, WOULD APPRECIATE REPORT OF ANY REPEAT ANY PAPERS AND DOCUMENTS RELATING TO THE OSWALD 1963 VISIT TO MEXICO CITY AND FOLLOWING INVESTIGATIONS THAT ARE STILL HELD IN THE STATION. IF ANY PLEASE DESCRIBE SO DECISION CAN BE MADE CONCERNING FORWARDING TO HQS. 4

4. SOME CONSIDERATION BEING GIVEN AT HQS TO MAKE FULL PUBLIC DISCLOSURE OF AGENCY HOLDINGS RELATING TO LEE HARVEY OSWALD ACTIVITIES DURING 1963 TRIP TO MEXICO CITY (WHICH IN PART MONITORED BY TAP AND PHOTOGRAPHIC SURVEILLANCE), AS WELL AS RELATED DEVELOPMENTS. SUCH PUBLIC DISCLOSURE WOULD OBVIOUSLY REVEAL [24] RELATIONSHIP, [24] AND AGENT TRUE NAMES INCLUDING POSSIBLE IDENTITY LESSEE OF HOUSES USED FOR PHOTO SURVEILLANCE. PLEASE PROVIDE US WITH YOUR CONSIDERED VIEW OF REACTION OF [24] AND MEXICAN GOVERNMENT AND POLITICAL AND OPERATIONAL CONNOTATIONS AND IMPLICATIONS IF A FULL PUBLIC DISCLOSURE WAS MADE. 4
